

**THE SPORT CHALET “SWAT College Winter Break 2010” SWEEPSTAKES
OFFICIAL RULES**

No Purchase Necessary to Enter or Win. Purchase and Non-Purchase entries have an equal chance of winning. VOID WHERE PROHIBITED BY LAW OR REGULATION. PARTICIPANTS MUST BE 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. THE JANUARY SWAT Winter Break 2010 TRIP WILL TAKE PLACE 1/15/10-1/18/10.

1. PROMOTION DESCRIPTION: The SWAT College Winter Break 2010 Sweepstakes (the “**Sweepstakes**”) begins on or about November 16, 2009 at 9:31 a.m. Pacific Time (“PT”) and ends on December 15, 2009 at 9:29 p.m. PT (the “**Promotion Period**”). At the end of the Promotion Period, a random drawing will be conducted from among all eligible entries received to select two (2) Grand Prize winners. Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sport Chalet, Inc., One Sport Chalet Drive, La Cañada, CA 91011 (the “**Sponsor**”) and COHEN-FRIEDBERG ASSOCIATES, LLC Framingham, MA 01702 (the “**Administrators**”), whose decisions shall be final and legally binding in all respects.

2. ELIGIBILITY: This promotion is open only to Sport Chalet Action Pass members who are legal U.S. residents (excluding Puerto Rico, U.S. Virgin Islands and Guam) at the time of entry, and who are eighteen (18) years of age or older at the time of entry. To become an Action Pass member is free; enroll for the Action Pass program at any Sport Chalet location. Employees, officers, and directors of Sponsor, Administrators, SWAT, Summer Winter Action Tours, LLC and each of their affiliated companies, subsidiaries, licensees, distributors, dealers, sales representatives, retailers, printers, individuals engaged in the development, production or distribution of materials, their advertising and promotion agencies, and any and all other companies associated with the promotion agents (collectively, the “**Promotion Entities**”), and each of their immediate family members (as defined by the IRS) and/or people living in the same household are not eligible to participate. Action Pass members: Action Pass members may enter by completing the Official Entry Form found at Point of Sale displays at all participating Sport Chalet retail stores between **11/16/2009 – 12/15/2009** (while supplies last).

Mail In: To enter by mail without any purchase necessary (available for all eligible entrants), hand print in ink your name, complete address, telephone number and age on a postcard and mail to: Sport Chalet “SWAT College Winter Break 2010 Sweepstakes”, PO Box 2274, Framingham, MA 01703-2274. Mail-in entries must be postmarked no later than 12/15/2009 and received no later than 12/18/2009. No photocopies, facsimiles or mechanical reproductions will be accepted. Sponsor is not responsible for lost, late, mutilated, misdirected, illegible, incomplete,

inaccurate, stolen, or postage due entries or mail. Personal information collected in connection with the Sweepstakes will be used in accordance with Sport Chalet's online privacy policy located at www.sportchalet.com/category/customer+service/privacy+policy.do

Limit: Limit: One (1) entry per person per method of entry.

NOTE: Entry must be made by the entrant only. Entries made by any other individual or any entity, including but not limited to commercial sweepstakes subscription notification and/or entering services, will be declared invalid and disqualified for this Sweepstakes. Tampering with the entry process or the operation of the Sweepstakes is prohibited and any entries deemed by Sponsor, in its sole discretion, to have been submitted in this manner will be void. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible.

4. PRIZES/ODDS: Only the number of prizes listed below will be awarded in this Sweepstakes. Odds of winning depend on the number of eligible entries received.

PLEASE NOTE: All travel arrangements must be booked through SWAT. Optional bus transportation available for purchase but not required. Travel arrangements cannot be changed in any way once booked and confirmed. Travel is subject to availability and certain travel restrictions may apply. No extension will be given after the trip has expired and prize will be forfeited and Sponsor will have no further obligation to winner. Winner is responsible for any and all local, state and/or federal taxes, as well as any other costs and expenses not specified herein as being awarded, including, without limitation, equipment, lessons, food, gratuities, gift shop purchases, incidentals, telephone calls or other personal expenses or hotel charges incurred. Winner and guest must have valid identification documents as required for hotel registration. Prize will be awarded only if the potential prize winner fully complies with these Official Rules. Taxes on any prize are solely the

responsibility of each winner. Prizes are non-assignable and non-transferable. All details and other restrictions of the any prize not specified in these Official Rules will be determined by Sponsor in its sole discretion. No cash alternative or substitution will be allowed, except Sponsor reserves the right in its sole discretion to substitute prize(s) of comparable value if any prize listed is unavailable, in whole or in part, for any reason. The prize restrictions/conditions stated herein are not all-inclusive and the Prizes described above may be subject to additional restrictions/conditions, which may be stated in the "Prize Claim Documents" (defined below). In the event the Prize winner or his or her guest engages in behavior that (as determined by Sponsor, SWAT or resort representatives and at their sole discretion) is obnoxious or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor, SWAT or resort representative reserves the right to terminate the applicable experience early, in whole or in part, with no further compensation.

- (3) WINNER SELECTION AND NOTIFICATION: The Grand Prize winners will be selected in a random drawing to be conducted on or about **December 22, 2009** from all eligible entries received throughout the Promotion Period. Conduct of the Sweepstakes and the drawing are under the supervision of the Administrators. Potential Prize winner will be notified in person and/or by phone and/or by email or mail or express mail, whichever is deemed appropriate by the Sponsor, using the contact information provided at the time of entry. Sponsor shall have no liability for any potential Prize winner notification that is lost, intercepted or not received by any potential Prize winner for any reason. If, despite reasonable efforts, any potential Prize winner does not respond within (5) days of the first notification attempt, or if the prize notification is returned as unclaimed or undeliverable to such potential Prize winner, such potential Prize winner will forfeit his or her prize and an alternate winner may be selected. If any potential Prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines a prize for any reason prior to award, such potential Prize winner will be disqualified and an alternate Prize winner may be selected. Sponsor may successively attempt to contact up to one (1) alternate potential winner in accordance with the above procedure, and if there is still no confirmed winner after such attempts have been made, the applicable prize may go unawarded.

WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, SUCH PRIZES ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, AND SPONSOR HEREBY DISCLAIMS ALL SUCH WARRANTIES, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND/OR NON-INFRINGEMENT.

- (5) PUBLICITY RELEASE: Acceptance of any Prize constitutes Prize winner's permission for the Promotion Entities to use Prize winner's name, photograph, likeness, voice, biographical information, statements and complete address (collectively, the "**Attributes**"), for advertising and/or publicity purposes worldwide and in all forms of media now known or hereafter devised, in perpetuity, without further compensation or authorization, (except where prohibited by law), and releases the Promotion Entities from all claims arising out of the use of such Attributes.

Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes if it determines, in its sole discretion, that the Sweepstakes is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other

causes beyond Sponsor's control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Sweepstakes as contemplated herein. In the event an insufficient number of eligible entries are received and/or Sponsor is prevented from awarding prizes or continuing with the Sweepstakes as contemplated herein by any event beyond its control, including but not limited to fire, flood, natural or man-made epidemic of health of other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis (e.g. SARS), order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each a "**Force Majeure**" event or occurrence), then Sponsor shall have the right to modify, suspend, or terminate the Sweepstakes. If the Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select the winner in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. Only the type and quantity of prizes described in these Official Rules will be awarded. If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the number of each type of prize set forth in these Official Rules, the winners, or remaining winners, as the case may be, of the advertised number of prizes available in the prize category in question may be selected in a random drawing from among all persons making purportedly valid claims for such prize(s). These Official Rules cannot be modified or amended in any way except in a written document issued in accordance with law by a duly authorized representative of Sponsor. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.

(7) GOVERNING LAW/JURISDICTION: ALL ISSUES AND QUESTIONS CONCERNING THE CONSTRUCTION, VALIDITY, INTERPRETATION AND ENFORCEABILITY OF THESE OFFICIAL RULES OR THE RIGHTS AND OBLIGATIONS OF ENTRANTS OR SPONSOR IN CONNECTION WITH THE SWEEPSTAKES SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE INTERNAL LAWS OF THE STATE OF CALIFORNIA WITHOUT GIVING EFFECT TO ANY CHOICE OF LAW OF CONFLICT OF LAW RULES OR PROVISIONS THAT WOULD CAUSE THE APPLICATION OF ANY OTHER STATE'S LAWS.

(8) ARBITRATION PROVISION: By participating in this Sweepstakes, each entrant agrees that any and all disputes the entrant may have with, or claims entrant may have against, the Promotion Entities relating to, arising out of or connected in any way with (i) the Sweepstakes, (ii) the awarding or redemption of any prize, and/or (iii) the determination of the scope or applicability of this agreement to arbitrate, will be resolved individually and exclusively by final and binding arbitration administered by the National Arbitration Forum (the "**Forum**") and conducted before a sole arbitrator pursuant to the Code of Procedure established by the Forum. The arbitration shall be held at a location determined by the Forum pursuant to the Code of Procedure, or at such other location as may be mutually

agreed by the participant and Sponsor. The arbitrator's decision shall be controlled by the terms and conditions of these Official Rules and any of the other agreements referenced herein that the applicable participant may have entered into in connection with the Sweepstakes. There shall be no authority for any claims to be arbitrated on a class or representative basis; arbitration can decide only the participant's and/or Sponsor's individual claims and the arbitrator may not consolidate or join the claims of other persons or parties who may be similarly situated. The arbitrator shall not have the power to award punitive damages against the participant or Sponsor. If any part of this Arbitration Provision is deemed to be invalid or otherwise unenforceable or illegal, the balance of this Arbitration Provision shall remain in effect and shall be construed in accordance with its terms as if the invalid or illegal provision were not contained herein.
